City of Newcastle is proposing the following traffic or parking amendment:

It is proposed to install 2P (9AM-5PM, Mon-Fri, 9AM-1PM, Sat, Permit Parking Excepted Precinct 16) restrictions along both sides of Daniel Street, Anderton Street, Wallace Street, Redman Street, May Street, Coal Street, and Chinchen Street Islington, in the connecting area bounded by Fern Street, Coal Street, Chinchen Street and Daniel Street.

The proposed changes are in response to requests from local residents to improve parking availability at the locations identified.

Observations of the area have indicated that on-street parking is frequently occupied by long-term parking which significantly reduces its availability for visitors and residents in the area.

The proposed changes will allow eligible residents to park with a permit and provide a higher rate of parking turnover for the public at the location. If responding, please include comments referring to specific streets.

Submissions

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed traffic or parking amendment. The submissions must specify:

- the reference number TR2023/01261,
- the submitter's name, residential address, contact number; and preferably an email address, and
- whether the submission is in support or objection of the proposal.

Submissions must be made in writing and should be lodged via the [online submission form](#) on City of Newcastle's website.

Alternatively, submissions can be made by mailed to PO Box 489, Newcastle NSW 2300 or delivered in person to the Customer Service Centre at 12 Stewart Avenue, Newcastle West NSW 2302.

All submissions received are considered 'Open Access Information' under the Government Information (Public Access) Act 2009 (GIPA) and therefore may be made available to the public.

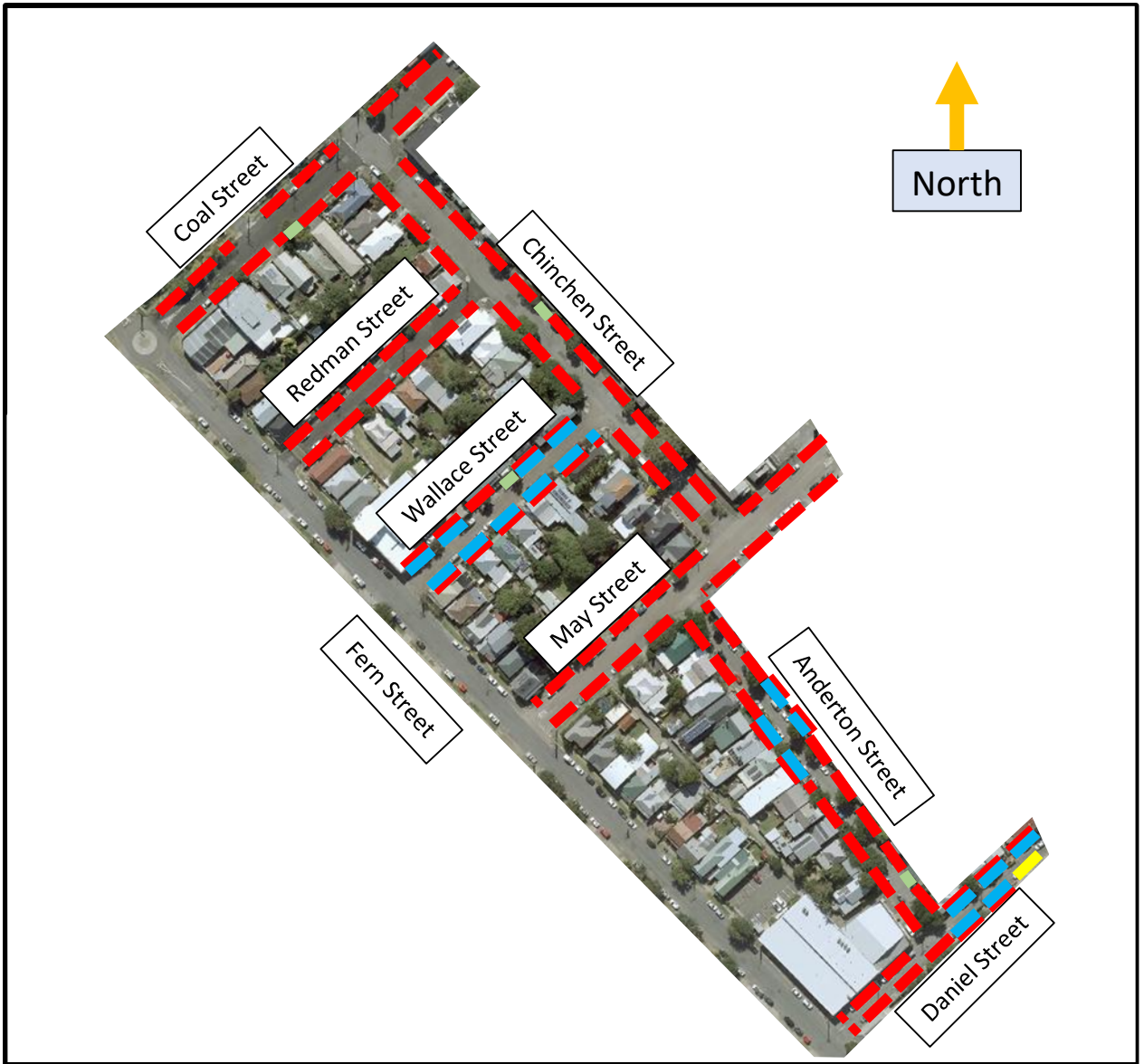
Following the closure of the submission period, the proposal and submissions received will be considered by the Newcastle City Traffic Committee at an upcoming meeting.





Submissions must be received by 5.00 pm on 6 November 2023.
